Conditions of Sale

TERMS: NET 60 DAYS FROM DATE OF INVOICE.

NOTE: Invoice date is 1 or 2 days after shipment.

CREDIT LIMITS: Credit limits will be established for each account based on payment history, financial information, and other factors. Credit limits will be reevaluated upon request.

STOCK BALANCING: Current products in salable condition may be exchanged on a 2-for-1 basis. Example: Return \$250.00 worth of product in exchange for \$500.00. Limit is \$300.00 in returns. ACCOUNT BALANCE MUST BE CURRENT.

BACKORDERS: We will automatically cancel any backorder which is on file for more than 60 days from the requested ship date. The cancellation date can be eliminated or changed at the request of the dealer. Please indicate with an order if you would like a cancellation date other than 60 days from the requested shipment. Dealers receive notice of cancelled orders, and are given option to reinstate.

PAST DUE ACCOUNTS: A finance charge of 1½ % per month is charged on past due accounts. It is our policy to hold shipments on past due accounts. When merchandise is in short supply, shipping priority will be determined by past payment history.

NEW DEALER ACCOUNTS: Please check with your sales representative for initial opening order requirements. To process a new dealership, we must have the dealer information form completed. Dun & Bradstreet listing will not be accepted in place of the financial statement.

SHIPPING: All shipments are FOB Boulder, Colorado unless otherwise indicated. A \$2.50 charge will be assessed for orders which require internal special handling or shipping. To avoid this charge, please plan far enough ahead so that special handling and/or shipping is not required.

FREIGHT ALLOWANCE: Standard UPS or truck (if it is less expensive) freight charges may be deducted from an invoice on ORDERS of MORE THAN \$500 scheduled to be shipped to a single location on a single day, IF THE PAYMENT IS POSTMARKED BY THE DUE DATE. Payments postmarked after the due date do not qualify for the freight deduction. Any other method of shipment will not be allowed this freight deduction.

REFUSED SHIPMENTS: Shipments are the sole responsibility of the customer. Liability rests with the retailer if the shipment is refused an a 15% restocking charge will be assessed on refused shipments.

DAMAGED SHIPMENTS: If the boxes look damaged or have been opened, note the problem on the bill of lading before signing for the shipment. It is your responsibility to institute claims with the carrier for damages or theft. If you have any problems with a carrier, please contact us and we'll do whatever we can to help.

RETURNS: Items returned to HINE/SNOWBRIDGE, Inc. will not be accepted without prior written permission and are subject to a restocking charge of 15%.

REPAIRS: Items returned to HINE/SNOWBRIDGE, Inc. for repairs should be prepaid and are sent at the dealer's cost and risk. Repairs which in our opinion fall under the terms of our warranty will be sent back to the dealer at no charge. Dealers will be invoiced for repairs (and return shipping charges) which, in our opinion, are not covered under the warranty. We reserve the right to determine if repairs fall under the warranty conditions.

ORDER CANCELLATIONS: In the event that it becomes necessary to cancel an order, the cancellation must be received in writing at HINE/SNOWBRIDGE no less than two weeks before the requested shipping date. If the cancellation is not received at least two weeks before the requested shipping date we cannot guarantee that the order will not have been processed for shipping. Orders which are cancelled after they have been processed for shipping will be subject to the standard restocking charge.
